4a (Code:) (Expenses \$ 44,250 including grants of \$) (Revenue \$ 55,736) HOME SERVICES AND SENIOR SUPPORT SERVICES: The Shepherd's Center provides two home services: Friends for Seniors is a friendly visitor program, which matches older volunteers with another older adult who may be homebound, or experiencing isolation. In 2015, 7 volunteers were matched with 8 older adults (one had 2 matches). The Minor Home Repair program includes 4 retired volunteers (along with some contractors, church groups, etc. who donate their time) who make minor repairs on the homes of lower to moderate older adults. In 2015, more than 100 projects were completed through this program. More than 330 volunteer hours were contributed for these home services.

4b (Code:) (Expenses \$ 25,173 including grants of \$) (Revenue \$ 4,020) OTHER PROGRAMS: Other programs of the Shepherd's Center of KCK include Adventures in Learning, a monthly series that includes informational and educational workshops, blood pressure screenings, chair exercises, entertainment, lunch and social networkings. Other programs include creative classes (such as crochet, knitting, scrapbooking and card making, plastic canvas), basic computer skills courses, exercise and health support groups, a book discussion group and a prayer shawl group. More than 592 participants were involved across these programs, and more than 900 volunteer hours were contributed to these programs.

4c (Code:) (Expenses \$ 8,855 including grants of \$) (Revenue \$ 425) NEXT CHAPTER PROGRAM: Next Chapter Kansas City is a program of the Shepherd's Center of KCK, which collaborates with other community agencies to provide help for persons in the "Baby Boomer" generation-in the second half of life, as they transition from work to their "next chapter." The initiative is designed to offer opportunities for meaningful civic engagement on a volunteer or paid basis. In 2015, Next Chapter Kansas City held 9 networking sessions with an average attendance of 25 each (225), 8 book group sessions averaging 8 persons each (64) and more than 170 volunteer hours were contributed by the 2 volunteer coordinators of this program.
